In March 2004, ESCORT Inc, the leader in radar, laser, and safety camera detection equipment, foresaw the potential negative impact hundreds of unmonitored online dealers could have on their business. With continued copyright infringement and trademark abuse on auction sites, trade boards, and unauthorized retail websites, lower brand equity would become the norm. There would be no way consumers would be able to tell the difference between legitimate dealers and illegitimate sellers of less than full quality goods and counterfeits.

Within months, Ron Gividen, ESCORT Inc's Tactical Marketing Manager, made the decision to engage Net Enforcers, Inc. to help monitor their top products online. With a focus on Online Channel Monitoring and Auction Monitoring solutions, Ron made it clear that results needed to be immediate. Within days, Net Enforcers team of analysts had identified several hundred auctions that were potentially misusing ESCORT Inc.'s intellectual property. To date, Net Enforcers has helped ESCORT Inc. remove over \$1.1 million worth of product violations on eBay and continues to monitor sites daily, detailing its findings to ESCORT Inc.'s executive team.
